POTTER REZONE (CASE NO. RZ-20-0012)
A REQUEST TO REZONE APPROXIMATELY 40.37-ACRES FROM AGRICULTURE (A) TO AGRICULTURE RESIDENTIAL (AR) AT 109 BOZEMAN TRAIL, ELIZABETH.

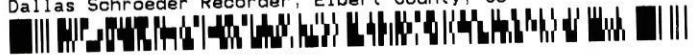
WHEREAS, the applicant Steve Potter has submitted an application (Case No. RZ-20-0012) requesting approval of a rezoning from Agriculture (A) to Agriculture Residential (AR); and

WHEREAS, Kathleen Potter is the current owner of the property subject to the proposed Rezoning request; and

WHEREAS, on November 16, 2021 the Planning Commission held a public hearing on the proposed Potter Rezone. At the hearing there were presentations by Staff and the applicant, and public comment was solicited. On a vote of 5-0, Planning Commission forwarded a recommendation of approval with conditions to the Board of County Commissioners for consideration; and

WHEREAS, the Board of County Commissioners, having found that the original hearing was properly noticed, and having reviewed the recommendation of the Planning Commission, and having reviewed the documentation of the applicant, and having listened to all public comment, and being fully advised in the premise;

BE IT THEREFORE RESOLVED, the Board of County Commissioners for the County of Elbert, Colorado does hereby approve the **POTTER REZONE Case No. RZ-20-0012**) with conditions of approval to include:



1. The applicant will be required to remove the public hearing sign within seven (7) days of a decision by the Board of County Commissioners; and
2. The Rezone to PUD shall not become effective until all fees are paid, conditions of approval are met, and the Rezone to PUD Exhibit is recorded; and
3. Recordation of all appropriate documentation to occur within 180 days of Board of County Commissioners' approval.

Upon a motion duly made and seconded, the foregoing resolution was adopted by the following vote:


