**RESOLUTION 14-25**

**A RESOLUTION ADOPTING A NEW ON-SITE WASTEWATER TREATMENT SYSTEM REGULATION #2014**

**WHEREAS**, C.R.S. 25-10-10, *et seq.*, the Colorado On-site Wastewater Treatment Systems Act, authorizes a Board of County Commissioners, sitting as a local Board of Health, to adopt detailed rules for on-site wastewater treatment systems within its area of jurisdiction; and

**WHEREAS**, the Board of County Commissioners has held a public hearing on the proposed rules; and has given notice of the time and place of the hearing at least once, at least twenty (20) days before the hearing, in a newspaper of general circulation within its area of jurisdiction, as required by C.R.S. 25-10-104 (2); and


**WHEREAS**, the Board of County Commissioners has determined that it is the public interest to establish minimum standards and rules for on-site wastewater treatment systems in unincorporated Elbert County, and to provide the authority for the administration and enforcement of those minimum standards and rules, in order to protect public health and water quality.


**NOW, THEREFORE BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ELBERT COUNTY, COLORADO** that the Board, sitting as a local Board of Health, hereby finally adopts the attached “Elbert County Department of Health and Human Services On-Site Wastewater Treatment System Regulation #2014, 5 CCR 1002-43, and hereby designates the Elbert County Department of Health and Human Services to implement this Regulation on behalf of the Board of Health. The Board of County Commissioners, sitting as a local Board of Health, further resolves that this Regulation shall be transmitted to the Colorado Department of Public Health and Environment no later than five (5) days after final adoption, and shall become effective forty-five (45) days after final adoption, unless the

department notifies the local board of health before the forty-fifth day that this regulation is not in compliance with C.R.S. 25-10-104, 25-10-105, or 25-10-106.
